- Matching funds can be requested for one-time cash, check, credit card, or stock donations, via the Merck Gives Back (MGB) website.
- 5. Matching gift requests will be accepted up to 180 days following the donation to the nonprofit organization. The annual donor limit is determined by the actual date of the donor's contribution to the recipient organization. For example, a donation made to an eligible organization on December 31, and submitted for matching funds in January of the following year, results in the matching funds award, if approved, applied to the prior year, which is the year the employee donation was made to the organization.
